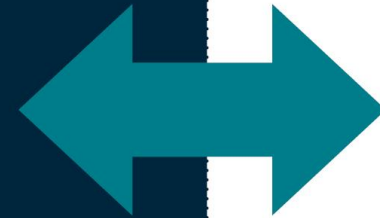

Sport Integrity means the manifestation of the ethics and values that promote community confidence in sport

- achieving a safe, fair and inclusive sporting environment at all levels
- promoting positive conduct by athletes, administrators, officials, supporters and other stakeholders, on and off the sporting arena
- achieving fair and honest sporting performances and outcomes
- enhancing the reputation and standing of sporting contests and of sport overall

The formation of Sport Integrity Australia

Sport Integrity Australia legislation came into effect 1 July 2020

Bringing together 3 agencies responsible for:

- Competition Manipulation and Sports Wagering (policy)
- Child Safeguarding and Member Protection (policy)
- Australia's National Anti-Doping Program

Coordination of a national approach to sport integrity matters:

- Policy Framework
- Integrity Capability
- Education
- Partnerships

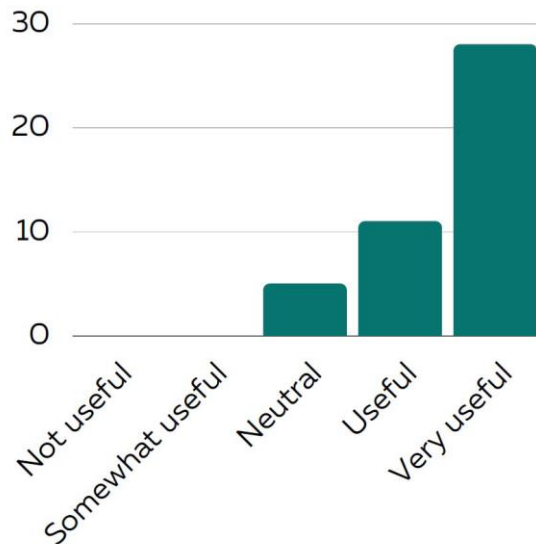

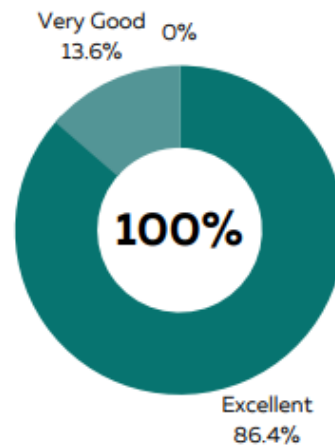

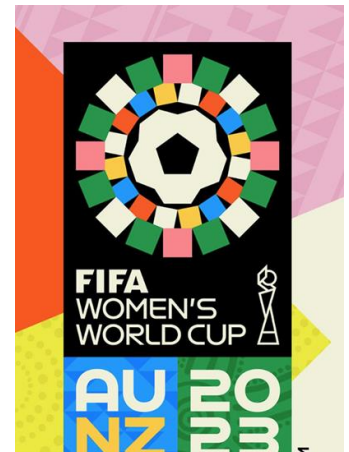
